This is a request from PAC Member City Manager for Kingsburg, Alex Henderson. SKF is invested in groundwater sustainability, but it must be beneficial to the rate payers as well as the District. Chairman Mendes is okay with going forward with PAC having a discussion provided it doesn't affect the District's discharge permit. City Engineer from Kingsburg who is also the Secretary for South Kings GSA, Dave Peters said that when the City of Selma is not using them in the springtime they could be utilized for this purpose. He said that the District would incur no cost, and the South County GSA would sustain any maintenance and infrastructure costs. There is a possibility that the State Water Board would ask for a study to be conducted, which would incur a fee. At this time Selma City Engineer David Horn spoke and said that those lines are currently being used by the City and they are undergoing a Master Plan at this time but understands that future ideas are possible.

SUBJECT: Consideration of Amendment No. 1 to Consulting Services Agreement with MKN and Associates for CCTV Inspection and Review

RECOMMENDATION

That the Board approve Amendment No. 1 to the Consulting Services Agreement with MKN and Associates for an additional cost of \$7,089.20 for the Fiscal Year 2023-2024 services and extending the Agreement for one year to conduct Fiscal Year 2024-2025 CCTV Inspection and Review for a not to exceed amount of \$155,000 and authorize the General Manager to execute the necessary agreements.

EXECUTIVE SUMMARY

The Board of Directors approved an agreement with MKN and Associates for CCTV Inspection and Review for Fiscal Year 2023-2024 in October 2023. That work is complete. However, there is an additional cost of \$7,089.20 due to additional cleaning needed for heavy debris and mobilization for the Selma sewer line. Staff is recommending extending the Agreement to allow for CCTV and Inspection Review services for Fiscal Year 2024-2025 at a negotiated not to exceed \$155,000 for those services. The amended agreement would also allow for the payment of the \$7,089.20 for the 2023-2024 work.

MKN and Associates has previously completed three years of CCTV and Inspection Review for the District. Staff recommends that MKN and Associates continue the televising and review of the sewer mains for this fiscal year. The CCTV Inspection and Review is an ongoing item to catalogue, and risk assess the collection system.

The District is under the Statewide General Waste Discharge Requirements for Sanitary Sewer Systems. In summary the purpose of the order is to reduce the number of sanitary sewer overflows from the collection system and implementation of a Sewer System Management Plan by the District. The Sewer System Management Plan contains 10 sections. The Sewer System Management Plan includes provisions for the proper management, operation, and maintenance of the collections system.

The CCTV Inspection and Review program complies with the General Waste Discharge Order for Collection System (WDR). The Operation and Maintenance Program in the WDR has requirements for regular visual and TV inspections of manholes and sewer mains. The CCTV and Inspection Review is programmed in the 10-year capital improvement plan.
